A CALIFORNIA PUBLIC BENEFIT CORPORATION

ONE: The name of this corporation is Sahaya International, Inc.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are

- To provide charitable assistance with social development projects and education of social, medical and environmental issues in developing countries.
- To collaborate with other non-profit organizations for providing wider support.

 - (c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.
